Sustainability in Europe: challenges, trends and actions

The contribution of the EU Multi-annual Financial Framework to sustainable development: opportunities and best practices

This session will present the financial opportunities for supporting in achieving the SDGs. The panel will focus on the key challenges that national governments face in integrating the SDGs (especially biodiversity and climate targets) into their budgeting processes during the EU Multi-Annual Financial Framework (MFF) 2021-2027, and how these challenges can be overcome. One way this is discussed is by looking at the lessons learned from the past budgeting cycles, particularly during 2014-2020 MFF and how these lessons can be applied to the current budgeting process. The panel will speak about how climate mainstreaming has been used in in the green deal and how nature protection also needs budgeting rules in the MFF. Moreover, bringing in SDG 16 perspective means speaking about what it means to build a transparent budget for sustainable development. Building accountable institutions means more than only being good watchdogs and careful implementers. For advisory councils and policy-makers, it means knowing what methodologies work for green and sustainable budgeting. Using the MFF and the ways that its policies have been implemented to guarantee good spending, we will outline how advisory councils have played and can play a role to increase accountability.
